What can be said about the **La Rosiere!** Located just over 2.5 hours from Geneva or Lyon International Airports, the San Bernardo domain is an international ski area located between France and Italy and just a few kilometers from Mont Blanc. The ski area has a peak of 2800m with runs extending 160km and is for skiers of all levels. This particular area is known as the "Balcony of the Tarentaise" for its exceptional 180 degree panoramic view. A quick 15 minute walk down the hill from the resort is a wonderful French village for apres' ski or a little shopping in the many boutiques.

From its perch at 1950 metres above sea level and facing south, the stone and wood **clad La Rosiere Resort Club Med** overlooks the entire Tarentaise valley. Built on the slopes, it dominates a bona fide resort, developed with consideration and affection by the inhabitants of Montvalezan. The Savoyard interior design tells the fabulous story of the mythical Petit St Bernard pass, from the crossing of the Alps by Hannibal with his elephants, to the pilgrims crossing the high mountain, to which the fresco in reception bears witness. ### After July 1, 2024 and up to 120 days prior to the scheduled departure, the cancellation policy is as follows:

- Any and all cancellations are subject to a \$95.00 pp contracted administration fee up until 120 days prior to departure;
- Any and all cancellations made 119 to 91 days prior to departure: \$295.00 pp contracted cancellation fee;
- Any and all cancellations made 90 – 61 days prior to departure: \$695.00 pp contracted cancellation fee; and
- Any and all cancellations made 60 days or less prior to departure: **no refunds**.
