Jackson is located in a valley surrounded by the Teton Range and the Absaroka Range of the Rockies and is located just outside the boundaries of Yellowstone and Grand Teton National Parks. Enjoy amazing views of the mountains as they rise from the valley floor to over 12,000 feet above you. You will enjoy seeing wildlife as diverse as Elk, Moose, Bald Eagles and Osprey as you ski, dine and shop in "The Hole." In Jackson, the Old West is still alive in one of the most charming towns you're likely to find anywhere. From the "local color" of the Town Square's elk antler arches to the unique shops and restaurants along the boardwalks, Jackson truly has something for everyone.

Some restrictions and penalties apply to your vacation investment. If you cancel your reservations, YOUR RIGHT TO A REFUND IS LIMITED, as set forth in the following schedule. All cancellations **must be discussed with your trip leader and be in writing and emailed to Alphorn Tours** at groups@alphorntours.com. Date of email will determine applicable policy:

After July 1, 2025 and up to 120 days prior to the scheduled departure, the cancellation policy is as follows:

- Any and all cancellations are subject to a \$95.00 pp contracted administration fee up to 120 days prior to departure;
- Any and all cancellations made 119 to 90 days prior to departure: \$395.00 pp contracted cancellation fee;
- Any and all cancellations made 89 – 45 days prior to departure: \$595.00 pp contracted cancellation fee; and
- Any and all cancellations made 44 days or less prior to departure: **no refunds**.

No refunds for early departures or late arrivals, no shows, expenses incurred for car rentals, airfare or unused portions of this package.
